- 1- The minimum turnover of the tenderer firm for the last year (2019-20) should be Rs. 50.00 lakhs.
- **2-** The tenderer firm should have minimum three year experience in construction activity within the mentioned district.
- **3-** The tender should be submitted in the prescribed tender form.
- **4-** The tender forms can be obtain from **President, M/s. Gyanpath Shiksha Evam Samaj Kalyan Samiti Bhopal** on any working day between 02/07/2020 to 03/07/2020 from 10.00 AM to 5.00 PM and up to 12.00 Hrs. on 02/07/2020 by payment of Rs. 500/-.
- **5-** Tender form should be deposited in separate envelopes containing Technical Bid and Financial Bid along with details of stalls, theme pavilion, cash counter and other facility along with earnest money of Rs 1,74,000/- at above address on or before 02.00 pm of 02/07/2020.
- 6- Earnest money can be paid through DD in favor of M/s. Gyanpath Shiksha Evam Samaj Kalyan Samiti Bhopal. The tender received will be opened before the Purchase committee on 03/07/2020 at 3.00 pm at M/s. Gyanpath Shiksha Evam Samaj Kalyan Samiti Bhopal.
- 7- The tender will be submitted in sealed envelopes separately for technical bid and financial bid. On each envelop "Tender for CFC at M/s. Gyanpath Shiksha Evam Samaj Kalyan Samiti Bhopal "should be written on the top of envelop. Technical Bid and Financial Bid should also be clearly mentioned on the envelop.
- **8-** The Technical Bid will be opened and considered first. The financial Bid of only eligible firms/agencies will be opened.
- **9-** Tenders received without earnest money will not be accepted.
- **10-** The tenderer firm should submit implementation plan of constructing the below mentioned shed and the details of the firm. Incomplete tender will not be accepted.
- **11-** The tendered firm should submit tender for the whole works. Tender for partly works will not be accepted.
- **12-** Technical Bid/ Financial Bid cannot be withdrawn after opening it. Earnest money can be forfeited in case of withdrawal of bid or not completing the work.
- **13-** If the work is not found as per specifications or unsatisfactory the payment of whole or equivalent amount can be withheld.
- **14-** The party has to enter into an agreement with **M/s. Gyanpath Shiksha Evam Samaj Kalyan Samiti Bhopal,**on the Stamp Paper of Rs. 100/- on prescribed Performa.
- 15- T.D.S. and other taxes will be deducted as per norms from the payments.
- **16-** President, **M/s. Gyanpath Shiksha Evam Samaj Kalyan Samiti Bhopal** has reserved the right to accept the bid partially/in full or may reject any or all the bids without assigning any reason.

17- The maximum time frame given for completion of construction is 6 months. The detailed work plans given as form No: 5, below.

#### 18. Materials to be used

- a) All materials shall be best of their kind and shall conform to the latest Indian Standards (CPWD norms applicable).
- b) All materials shall be of approved quality as per samples and approved by the concerned authority.
- i) Cement: Shall comply with the latest specifications confirming to IS: 8112 for 43 grade OPC and IS 12269 for 53 grade cement.
- **ii) Reinforcement**: High Yield Strength deformed bars conforming to IS 1786 1990 Fe 500(thermo mechanically treated bars) and Mild Steel confirming to IS432(part-1).
- **iii)** Coarse Aggregate: Shall be of the best quality, hard machine crushed stone free from earth or any organic matter etc. Suitably graded and shall conform to IS: 383-1990
- **iv**) **Sand**: Shall be river sand clean, sharp, strong, angular and composed of hard siliceous materials. It shall be free from any harmful materials such as iron pyrites, coal mica, shale, clay alkali, soft fragments, sea shale, organic impurities, etc. It shall be obtained from approved quarries and shall conform to IS:383-1990
- v) **Bricks**: It shall be first class table molded bricks, well burnt, sound, hard square and with sharp edges and shall conform to Indian Standards 1077 1992 having strength of 35 kg/sq.cm(3.5N/mm2) as specified in the item.
- vi) Timber: Shall be of best quality, perfectly dry, well-seasoned and free from sap wood, sound straight, free from loose knots, cracks shakes and any appearance of root and any other defect and conforming to IS: 12896 1990. No wood work shall be placed in position covered in the wall unless it is approved by the Architect
- **vii**) **Hardware Fittings for Doors**: All the doors shall be provided with MS powder coated hinges, tower bolts, locks etc. or as specified in schedule of quantities. The external doors shall be provided with Godrej make locks.
- **ViIi) Admixtures**: Admixtures if used shall comply with IS 9103. Admixtures to concrete shall not be used without the written consent of the Architect. When permitted, the contractor shall furnish full details from the manufacturer and shall carry such test as the Architect may require before any admixture is used in the work to check particularly for Chlorides.
- **ix) Admixture** may be used to modify one or more of the following properties of FRESH CONCRETE.
  - a) To increase workability without increasing water content or to decrease the water content at the same workability.
  - b) To retard or accelerate both initial and final setting times.
  - c) To reduce or prevent settlement.
  - d) To increase slight expansion in concrete and mortar.
  - e) To modify the rate or capacity for bleeding or both.
  - f) To reduce segregation of concrete, mortars and grouts.

- g) To improve penetration & or pump ability of concrete, mortars & grouts.
- h) To reduce rate of slump loss
- xv) Admixtures may also be used to modify one or more of the following properties of: HARDENED CONCRETE:
  - (1) To retard or reduce heat generation during early hardening.
  - (2) To accelerate the rate of strength development.
  - (3) To increase the strength of concrete or mortar (Compressive, tensile or flexural).
  - (4) To increase the durability or resistance to severe conditions of exposure including the application of devising salts.
  - (5) To decrease the capillary flow of water.
  - (6) To decrease the permeability to liquids.
  - (7) To control the expansion caused by the reaction of alkaline with certain aggregate constituents.
  - (8) To produce cellular concrete.
  - (9) To increase the bond of concrete to steel reinforcement
  - (10) To increase the bond between old and new concrete.
  - (11) To improve impact resistance and abrasion resistance.
  - (12) To inhibit the corrosion of embedded metal.
  - (13) To produce colored concrete or mortar.
