- 40% of total billing amount against proof of dispatch of P&M from the supplier's premises
- 30% of the total billing amount on delivery of P&M at the purchaser's site.
- 20% of the total billing amount after successful installation, testing and commissioning of the P &M in all respect at the purchaser's site and after clearance from the purchase committee/ competent authority.
