FMC and H&M Foundation Drive Circular Textile Transformation in Panipat

FMC, with support from the H&M Foundation, organised a field visit and discussion in Panipat to advance circular textile recycling and improve working conditions. MSMEs, recyclers, and experts co-created strategies for cleaner production and fair labour practices. The dialogue, enriched by global insights on circularity and just transition, concluded with a shared commitment to make Panipat India's model for inclusive and sustainable textile recycling.



GIZ and FMC Launch 'Net Positive Panchayats' in Goa for Climate-Resilient Governance



In partnership with GIZ India, FMC launched the 'Net Positive Panchayats – Goa' project in the presence of Hon'ble Chief Minister Shri Pramod Sawant. Focused on renewable energy, waste management, and agroecology, the initiative aims to make village panchayats climate-resilient and resource-positive. Implemented across Harvelam, Kavrem Pirla, and Calangute, it contributes to Goa's Energy Vision 2050 and India's climate targets, fostering self-reliant, sustainable local governance.

FMC at SWITCH-Asia Annual Meet: Scaling Circular Economy Solutions from India

At the 7th EU SWITCH-Asia Annual Meeting in Bangkok, FMC shared India's experience in promoting circular textile production under the Green Threads Project. Supported by the European Union's Global Gateway, the event gathered 160 policymakers and experts. FMC showcased how shared infrastructure and cleaner production practices reduce emissions and costs, positioning India as a leader in advancing resource-efficient, circular economies across Asia.



Bamboo for Climate and Livelihoods: FMC Marks World Bamboo Day in Mumbai



On World Bamboo Day, FMC led a dialogue in Mumbai with experts from FRI Dehradun, KFRI Kerala, and MGNREGA Mission Maharashtra on sustainable bamboo cultivation. Discussions focused on species selection, harvesting cycles, and market-aligned cultivation. The initiative supports FMC's broader mission of promoting bamboo as a renewable raw material for livelihood generation and climate resilience.

Cluster Samvaad Spurs Panipat MSMEs on Path to Decarbonisation

Over 25 MSMEs participated in 'Cluster Samvaad: Towards Cleaner Production and Decarbonisation', organised by FMC and the Centre for Responsible Business (CRB). Supported by HSBC, the event linked MSME innovation with India's net-zero goals. Participants explored ways to cut emissions, enhance efficiency, and adopt sustainable production, building capacity for cleaner, climate-smart industrial growth.



Tribal Women Lead Millet Enterprise Revolution in Odisha



Supported by the SBI Foundation, FMC is empowering tribal women in Odisha's Gajapati district to build millet-based enterprises. Through training on processing, branding, and marketing, the initiative strengthens food security, women's income, and rural entrepreneurship. The project aims for ₹3.75 crore turnover, enabling each woman to earn ₹4,000 more monthly, turning traditional grains into engines of prosperity and self-reliance.

Financial Health for Micro Entrepreneurs: FMC-HDB Project Aims to Reach 15,000 Units



With support from HDB Financial Services, the Aarthik Aarogyam Kendra initiative, implemented by FMC, has kickstarted in Varanasi to enhance the financial resilience of 15,000 nano and micro enterprises across Delhi and Uttar Pradesh.. By promoting digital literacy and sound financial management, the project helps entrepreneurs access credit, manage finances better, and integrate with formal systems, strengthening India's inclusive financial ecosystem.

Reviving India's Handloom Heritage with HCL Foundation



In partnership with HCL Foundation, FMC is revitalising handloom clusters in Telangana, Odisha, Assam, and Madhya Pradesh. Over 50 artisans and 20 BMOs have been trained in digital marketing and connected to markets through My E-Haat and exhibitions. The initiative promotes fair incomes, cultural preservation, and sustainable livelihoods through heritage-based enterprise development.

FMC and Mahindra Finance Empower Micro Entrepreneurs Through Dhan Samvaad 2.0



As a partner in Mahindra Finance's Dhan Samvaad 2.0, FMC is advancing financial and digital inclusion for micro and nano entrepreneurs in Haryana, Delhi, and Uttar Pradesh. Between September–October, over 6,500 beneficiaries received training, 5,000 activated DigiLockers, and 4,400 linked to government schemes. The initiative strengthens financial access, digital confidence, and small business resilience.

FMC, The Asia Foundation, and Google.org Strengthen MSME Cyber Resilience



Under the APAC Cybersecurity Fund, FMC, in collaboration with The Asia Foundation and supported by Google.org, is helping MSMEs safeguard their digital systems. Over 25,000 MSMEs and 42 BMOs across 10 states have been trained in cybersecurity. Karnataka hosted state Learnshops, while Maharashtra conducted 1,600 sessions. The initiative ensures that India's digital growth is secure, inclusive, and future-ready.

POLICY UPDATE

Schemes to bolster the Micro, Small, and Medium Enterprises (MSME) sector

- **MSME Green Growth Initiative:** Launched by the Ministry of MSME, Government of India, in September 2025, this initiative aims to promote green technology adoption, energy efficiency, and waste-to-wealth practices among MSMEs.
- **Tamil Nadu MSME Export Readiness Scheme:** Launched by the Department of MSME, Government of Tamil Nadu, in September 2025, this scheme aims to enhance the global competitiveness of export-oriented MSMEs by providing financial incentives for quality certification, participation in trade fairs, and logistical support.
- **Digital Udyam 2.0:** Introduced by the Ministry of MSME, in collaboration with the Ministry of Electronics and Information Technology (MeitY), in September 2025, this scheme aims to advance digital transformation of MSMEs through e-commerce tools, AI-based analytics, and simplified compliance systems.
