Brief About Foundation for MSME Clusters

Established in June 2005, the **Foundation for MSME Clusters (FMC)** www.fmc.org.in specializes in the promotion of MSMEs through cluster and value chain led development. FMC was promoted as a Registered Public Charitable Trust with the technical support of a then UNIDO Cluster Development Programme, in June 2005. The project, "Digitalization to Employment (D2E): Empowering Women Artisans of India" aims to enhance the livelihoods of women artisans through a multi-faceted intervention targeting 25,000 women in FY 2026-27. Under the project in 1 year, 3000 embroidery-based women artisans need to be capacitated in drawing, idea creation and colour theory and 200 designs need to be developed from them.

Scope of work

Consultant will help FMC to create new designs as per contemporary market requirement in textile based artisanal products, sample development as per new designs created, provide handholding support/training to artisans in development of new samples and execution of production order generated-as per new designs created. Guide, follow up with production team for timely execution of these business orders from the selected artisanal clusters along with visit to these clusters to understand the design skill and production.

1. 100 market led new contemporary designs created for textile based artisanal products.
2. Develop 300 new sample products out of the new contemporary designs created.
3. Handhold, guide Junior Textile Trainers/Design Executives and Master Artisans in sample development
4. Assess capacity of artisans at the cluster including master artisans in creation of new samples and for follow up production as per order
5. Visit to clusters for handholding artisans/master artisans and observing sample creation and production
6. Undertake on the job trainings of lead artisans/artisans in new sample development and production
7. Discussion with buyers and receiving feedback on new designs/samples and production execution
8. Coordination with sales & marketing person and participate in buyers' meetings for the linkage created by the marketing person
9. Provide Monthly Reports and present during internal meetings and meetings with clients
10. Provide suggestions for participation in leading artisanal exhibitions in India
11. Visit to cluster during sample development as per requirement
